



**ACTS OF CANVASSING BOARD
Monday, June 17, 2013
Hinton City Hall - 1:00**

I. Call to Order

Mayor Blankenship called the meeting of the Board of Canvassers to order all members were present. City Manager Cris Meadows opened the meeting with a prayer and then led the pledge of allegiance. Cris then explained the procedure for canvassing the ballots and handed each member present one of the precinct packages.

II. Canvass of the Ballots for the General Election held June 11, 2013

Upon this the 17th day of June 2013, being the fifth day following the General election held in the City of Hinton, West Virginia, the Council of said city, sitting as a Board of Canvassers, proceeded to canvass said returns by opening each package of ballots laid before them and counting the number of ballots to be exact with the number of poll slips with the results as follows:

There were five provisional ballots brought by Cris that the voters were not in the registration books it was decided on a motion by Councilman Meador and seconded by Councilman Basham not to accept the ballot due to the voters not being registered in the books. The motion passed on a vote of all ayes.

There were four absentee ballots found in the box for Precinct 11 that were unopened and Councilman Jordan moved to allow the four absentee ballots to be counted. Councilman Meador seconded the motion and the motion passed on a vote of all ayes. Those votes were as follows Joe Blankenship 2, Cleo Mathews 2, Bob Basham 3, Roberta Sorg 3, Charles Oxley 1, Pat Jordan 2, and Larry Meador 2.

All the Ballots were sealed and placed in a storage box to be secured. After which the said board of canvassers examined the returns of the General Election and having ascertained the results hereby record the same in the following form, to wit:

Upon motion by Councilman Meador and Seconded by Councilman Basham the Board of Canvassers hereby publicly declare the results of the June 11, 2013 General Election official. The election will be considered final on Thursday June 20, 2013.
