City Council of Hinton
Regular Meeting
Thursday January, 23 2014
7:00 p.m. -- Hinton City Hall**

1. Call to order/Roll Call – Mayor Joe Blankenship called the meeting to order and the record showed that Council President Larry Meador, Councilwoman Roberta Sorg, and Councilman Pat Jordan were all present. City Manager Cris Meadows, Chief of Police Derek Snavelly, and City Attorney Richard Gunnoe were also in attendance. Councilman Bobby Basham was present by teleconference.
2. Invocation / Pledge of Allegiance – Cris Meadows led the prayer and the pledge of allegiance.
3. Approval of Agenda – Councilman Jordan moved to approve the agenda. Councilman Meador seconded the motion and the motion passed on a vote of 4-0.
4. Approval of Minutes- Councilman Meador moved to approve the minutes of the December 2013 regular city council meeting. Councilwoman Sorg seconded the motion and the motion passed on a vote of 4-0.
5. Approval of Paid Invoices – Councilman Jordan moved to approve the paid invoices. Councilman Basham seconded the motion and the motion passed on a vote of 4-0.
6. Approval of Financial Report December 2013 – Councilman Jordan moved to approve the financial report December 2013. Councilman Basham seconded the motion and the motion passed on a vote of 4-0.
7. Approval of Building Permits – Councilman Jordan moved to approve the building permits. Councilwoman Sorg seconded the motion. The motion passed on a vote of 3-0. Councilman Basham abstained on his permit and Councilman Meador abstained on his permit.
8. Appearance of Citizens – Joel Lorenz brought to councils attention trash piled up on CSX property under the bridge. Julia Gaitor gave a yearly report for the Campbell Flannigan Murrell House and asked that the city give a yearly budget amount to the board to support its activities and rehab. Council stated they would look at that during the budget process in March.
9. Discussion and or action regarding Brooks Sewer Project – Mayor Blankenship gave a report on the status of the project. Councilman Meador moved to approve the payment of \$46,486.85. Councilman Jordan seconded the motion and the motion passed on a vote of 4-0.
10. Discussion and or action regarding Gold Coast Project – Councilman Meador moved to approve the payment of \$211,339.64. Councilman Jordan seconded the motion and the motion passed on a vote of 4-0.
11. Discussion and or action hiring policeman – Mayor Blankenship asked for permission to hire a policeman. Councilman Meador moved to allow the Mayor and Chief to hire a

policeman. Councilman Jordan seconded the motion and the motion passed on a vote of 4-0.

12. Discussion and or action regarding hiring a Daycare Director – Councilman Meador moved to allow the mayor and city manager to hire the daycare director. Councilman Jordan seconded the motion and the motion passed on a vote of 4-0.

13. Adjournment – Councilman Jordan moved to adjourn the meeting. Councilman Basham seconded the motion and the motion passed on a vote of 4-0.
