I. Call to Order

Mayor Mathews called the meeting of the Board of Canvassers to order all members were present. City Manager Cris Meadows explained the procedure for canvassing the ballots and handed each member present a precinct packages.

II. Canvass of the Ballots for the Primary Election held April 7, 2009

Upon this the 10th day of April 2009, being the third day following the Primary election held in the City of Hinton, West Virginia, the Council of said city, sitting as a Board of Canvassers, proceeded to canvass said returns by opening each package of ballots laid before them and counting the number of ballots to be exact with the number of poll slips with the results as follows:
